Department News

Four instructors in the Department of Psychology and Neuroscience (out of a total of 25 across the University) were named the winners of Carolina's 2020 University Teaching Awards! Congratulations to Dr. Donald Baucom, Richard Simpson Distinguished Professor of Clinical Psychology, Dr. Steve Buzinski, Teaching Associate Professor, Dr. Viji Sathy, Teaching Associate Professor, and Zachary Buchin, a graduate student in Cognitive Psychology!

Dr. Baucom was awarded the Distinguished Teaching Award for Post-Baccalaureate Instruction, an award that was created by the University in 1995 to recognize the important role of post-baccalaureate teaching.

Dr. Buzinski was awarded the Tanner Award for Excellence in Undergraduate Teaching, which were created in 1952 in memory of Lola Spencer and Simpson Bobo Tanner. The award was established to recognize excellence in inspirational teaching of undergraduate students, particularly of first-year and second-year students.

Dr. Sathy was awarded the Chapman Family Teaching Award, which was created in 1993 with a gift by Max Carrol Chapman Jr. '66. The awards were established to honor distinguished teaching of undergraduate students.

Zach was awarded the Tanner Award for Excellence in Undergraduate Teaching by a Graduate Teaching Assistant. The Tanner Awards were expanded in 1990 to recognize excellence in the teaching of undergraduate students by graduate teaching assistants.

Congratulations to the 2020 University Teaching Award winners, who were selected for these honors due to their commitment to the care of our students, outstanding mentorship, and effective use of classroom methods!

The Clinical Psychology Program, our doctoral degree program, has been ranked #2 in the 2020 U.S. News and World Report of Best Clinical Psychology Programs!

U.S. News and World Report first ranked graduate programs in 1987 and has done so annually since 1990. Its annual rankings are based on expert opinions on program excellence and statistical indicators that measure the quality of a school's faculty, research, and students. Its rankings are based on the ratings of peer academic experts, including deans, program directors, and faculty. Surveys for the 2020 rankings were conducted during Fall 2019 and early 2020. Our Clinical Psychology Program in the Department of Psychology and Neuroscience was ranked #2—one of the top clinical psychology programs in the nation.



Margarett McBride, a graduate student in Developmental Psychology, and Aaron Neal, a graduate student in Clinical Psychology, are recipients of 2020 Ford Foundation Predoctoral Fellowships. Dr. Mitch Prinstein, a John Van Seters Distinguished Professor of Clinical Psychology, is the recipient of the 2020 Society for a Science of Clinical Psychology's Lawrence H. Cohen Outstanding Mentor Award. This award recognizes outstanding mentors who have provided exceptional guidance through leadership, role modeling, advising, supervision, instruction, advocacy, and other activities aimed at providing opportunities for scientific growth, professional development, and networking. Dr. Regina Carelli, a Stephen B. Baxter Distinguished Professor of Behavioral and Integrative Neuroscience, and the Behavioral and Integrative Neuroscience Program has received a training grant renewal from the National Institute on Drug Abuse for their Pre-doctoral Training in Addiction Science Program. This training grant offers graduate students pre-doctoral training in research on addiction science and interdisciplinary training in research areas related to drug and alcohol abuse. The T32 renewal provides over \$1.7 million for a period of five years, which will bring our grant into its 35th year of continued funding—an impressive achievement!



Mallory Feldman, a graduate student in Social Psychology, is the recipient of a 2020 research grant from the Love Consortium. The Love Consortium supports graduate student research regarding the science of love in collaboration with a research who has relevant data described on the Love Consortium Dataverse. 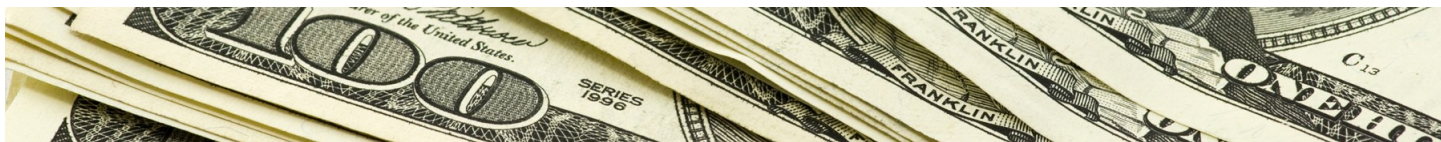
