Mitch Prinstein, Ph.D. and Eva Telzer, Ph.D. will serve as co-directors of a center to study effects of technology, social media on child brain development,

UNC-Chapel Hill and Winston Family Foundation launch national center to study effects of technology, social media on child brain development. The new research center at the University of North Carolina at Chapel Hill will examine the long-term effects of technology and social media use on teen social and emotional development, thanks to a \$10 million gift from the Winston Family Foundation. The Winston National Center on Technology Use, Brain and Psychological Development will create more tools for parents, caregivers and teens to make better informed choices about how they interact with technology and social media.

Mitch Prinstein, Ph.D., ABPP, chief science officer at the American Psychological Association and John Van Setters Distinguished Professor of Psychology and Neuroscience at UNC-Chapel Hill, and Eva Telzer, Ph.D., a UNC-Chapel Hill associate professor of psychology and neuroscience, will serve as co-directors of the new center, evolving from their current co-directorship of Wi-Fi. Their preliminary research indicates teenagers spend more than eight hours daily on cell phones, with a significant portion of time on social media. The Winston National Center will further explore the links between teens' online behavior and a range of mental health symptoms.

Justice, Equity, Diversity, and Inclusion Updates

There are a number of updates from the Justice, Equity, Diversity and Inclusion committee. First, in connection with the Faculty Recruitment and Retention subcommittee, we are excited to announce two new hires in the Department, Julian Rucker and Dalal Safa.

Julian Rucker will be joining us as an Assistant Professor in the Social area. Dr. Rucker is currently a [Carolina Postdoctoral Program for Faculty Diversity Fellow](#). Broadly, Julian is interested in the psychological factors shaping perceptions of, and motivations for, reducing racial inequality across several societal domains. His primary research examines how the lay tendency to associate racism with interpersonal biases, or with the structural disadvantage of racial groups, influences beliefs about societal racial inequality.

Dalal Safa will be joining us as an Assistant Professor in the Developmental area. Dr. Safa is currently an NSF SBE Postdoctoral Research Fellow at the Harvard Graduate School of Education. Her program of research examines antecedents and consequences of biculturalism. She is currently funded by NSF and SRCD to investigate the mechanisms by which immigrant and ethnic-racial minority adolescents develop bicultural identities and competencies, and the associations between bicultural identity formation processes and positive development.

The Education subcommittee successfully held a workshop on the afternoon of March 11, entitled “Inclusive Research Practices.” Facilitated by NC TraCS, this workshop went over first-hand experiences from researchers in the Psychology and Neuroscience Department and how they used TraCS to help diversify their research samples and practices.

The Justice, Equity, Diversity and Inclusion committee has [8 subcommittees](#), each lead by two faculty members. In this newsletter we wanted to highlight the work of the Faculty Recruitment and Retention subcommittee chaired by [Drs. Jennifer Arnold](#) and [Daniel Bauer](#). As with all subcommittees this year the Faculty R&R subcommittee is pursuing goals in line with the overarching aims laid out by the JEDI committee – focusing on representation, restructuring, and retention (see our [blurb](#) in the November 2021 newsletter!).

With regards to [representation](#) the Faculty R&R subcommittee is focused on successfully recruiting BIPOC faculty through utilizing existing mechanisms such as the [VITAE](#) (Valuing Inclusion to Attain Excellence) and the [Carolina Postdoc](#) hiring program and by helping to recruit diverse candidates for all new positions within the department.

This semester, the department, with the help of the Faculty R&R subcommittee successfully recruited [Anna Kwaennison Fetter](#) as a Carolina Postdoc. She will be working closely with Dr. Margaret Sheridan and others in the Developmental and Clinical Psychology as well as with scholars across campus when she comes to UNC in the fall (Go Tarheels!). Her work focuses on investigating culturally specific risk and resilience factors in adolescents and young adults who identify as indigenous or Native American in the US.

With regards to [retention](#) the Faculty R&R subcommittee has focused on feedback to the leaders in the department about enhancing the mentorship provided to junior faculty through workshops and enhanced acknowledgement of service around this kind of mentorship. With regards to [restructuring](#) the Faculty R&R subcommittee has focused on making changes to how materials for recruitment of faculty are made available to committees to increase the likelihood that a diverse group of candidates are recruited for every potential hire!

This year's speaker is Kafui Dzirasa, MD, PhD, a K. Ranga Rama Krishnan Associate Professor with appointments in the Departments of Psychiatry and Behavioral Sciences, Neurobiology, Biomedical Engineering, and Neurosurgery at Duke University.

With expertise in understanding the science and treatment of depression and schizophrenia, and expanding education and access to mental wellness for all, Dr. Kafui Dzirasa is an elected member of the National Academy of Medicine, winner of many awards including the Society for Neuroscience Young Investigator Award and the McArthur Foundation Award, and is a Howard Hughes Investigator. He has also been awarded the One Mind Rising Star Award and the Sydney Baer Prize for Schizophrenia Research, recognized as 40 under 40 in Health by the National Minority Quality Forum, and the Engineering Alumni of the Year from UMBC. Dr. Dzirasa received the Presidential Early Career Award for Scientists and Engineers: the nation's highest award for scientists and engineers in the early stages of their independent research careers, as well as the Alan Leshner Public Engagement Fellowship from the American Association for the Advancement of Science and the Society for Neuroscience Young Investigator award given to the best young brain scientist in the world. Dr. Dzirasa has served as an Associate Scientific Advisor for the journal Science Translational Medicine, and he was a member of the 17-member Next Generation Research Initiative mandated by Congress. He has also served on the Editorial Advisory Board for TEDMED, the Advisory committee for the NIH Director for the BRAIN Initiative, and an Investigator in the Duke Institute for Brain Sciences.

Call for Nominations for 2022 Graduate Diversity Enhancement Awards - The Department of Psychology & Neuroscience at UNC Chapel Hill honors two graduate students each year for their contributions to diversity in research. Winners will be recognized with a certificate/plaque and will be announced at the **Department Awards Ceremony on May 4th (time is TBD)**.

The purpose of the **Bernadette Gray-Little Award for Diversity Enhancement in Psychological Research** is to encourage and honor graduate students who make a contribution to the advancement of knowledge concerning issues that face diverse populations or that are of concern to diverse populations. This award will be given to one graduate student whose work best exemplifies a contribution to psychological knowledge about diversity. For this award, diverse populations are defined as groups who have been traditionally underrepresented in the psychological research of a particular research topic, including but not limited to race, culture, ethnicity, sexuality, gender, disability, religious affiliation, age, and socioeconomic status. Innovation in Equity and Inclusivity Awards Selection Criteria:

Significance - How has the nominee demonstrated a commitment to creating a culture of inclusion within their areas of influence or implemented initiatives which cultivate, advance, or model diversity and equity within the Carolina community?

Innovation - How has the nominee’s contribution uniquely addressed key issues of diversity and social justice within the Department of Psychology & Neuroscience or broader UNC community? How does this contribution build on or innovate from existing activities?

Impact - What have been the measurable outcomes and sustainability of these contributions? How has this project/program/activity “moved the needle” in addressing issues of social inequality throughout the Department of Psychology & Neuroscience and UNC/or the community?

The award will recognize individuals with outstanding accomplishments and general impact in any or all of the following areas:

Research

- Creation of new tools or advancement of new knowledge that has the potential to improve the quality of life among historically marginalized groups in the nominee’s field of study.
- Engagement in innovative research that enhances our understanding of diversity and marginalization and improves access and opportunity.
- Development and implementation of effective strategies that address unique barriers and increase representation and inclusivity of historically underrepresented populations in research.

Teaching/Mentoring

- Development and implementation of effective strategies for teaching that advances educational opportunity for students from historically excluded groups; activities can include innovative classroom instruction and advising (undergraduate or graduate students).
- Mentoring undergraduate or graduate students who are members of groups which are historically or currently underrepresented in their field and/or whose background and experiences contribute to campus diversity.
- Creating curricula that enable the development of student intercultural competence to navigate today’s global and multicultural realities.
- Implementing effective strategies or policies that address specific and unique barriers to higher education and the professoriate for students from historically or currently excluded groups.

Service/Outreach

- Promoting the professional and/or academic advancement and well-being of historically or currently excluded groups in the applicant’s field.
- Enhancing diversity and equity through activities such as recruitment and mentoring of faculty and students.
- Participating in exceptional sustained committee work or administrative service that has enhanced policies or processes that address social inequity and advance principles of diversity and inclusion.
- Contributions to department culture, practices, or programs that have had a demonstrable and important effect in helping the department address social inequality in the UNC community.

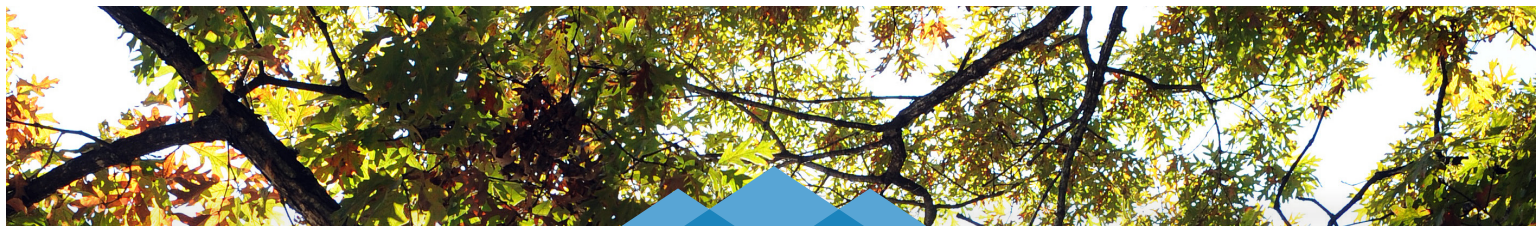
